

## **UFL Trade Promotion Lottery – Terms & Conditions (VIC Template)**

**Promotion name:** *Fight Free February Giveaway*

**Promoter:** Umbrella Family Law Pty Ltd (ABN: **91 625 259 430**) of *142-144 Albert Road, South Melbourne, Victoria* (“Promoter”)

**Trade promoted:** Umbrella Family Law’s Fight Free February / related services (“Trade”)

**Promotion period:** Opens *9:00am, 5 January* and closes *11:59pm, 16 February 2026* (“Promotion Period”)

**Entry is free.**

These Terms & Conditions apply to the above trade promotion lottery (“Promotion”) conducted in Victoria in accordance with the *Gambling Regulation Act 2003 (Vic)* and *Gambling Regulations 2015 (Vic)*.

### **1) Prior Written Consent (Reg 59(a))**

This Promotion is conducted to promote the Promoter’s trade/business and is conducted with the Promoter’s prior written consent.

### **2) Purpose of Promotion (Reg 59(b))**

This Promotion is conducted primarily to benefit and promote the trade/business of Umbrella Family Law.

### **3) Eligibility (Reg 59(c)(iv))**

Entry is open to **Australian residents aged 18 years or older**.

The following people are not eligible to enter:

- employees of the Promoter and their immediate family members; and
- any person directly involved in managing, administering, or judging the Promotion.

### **4) How to Enter**

To enter, eligible entrants must complete the following during the Promotion Period:

**Entry limit:** One (1) entry per person.

The Promoter may, at its discretion, deem an entry invalid if it is incomplete, illegible, misleading, or not submitted in accordance with these Terms & Conditions.

### **5) Promotion Information (Reg 59(c))**

All information likely to induce entry will include:

- **Closing date:** *11:59pm, 16 February 2026* (Reg 59(c)(i))
- **Draw details (if applicable):** *5 March 2026* (Reg 59(c)(ii))
- **Publication details:** Winners will be notified via email for at least **28 days** (if required) (Reg 59(c)(iii) & 59(d)(ii))
- **Eligibility requirements:** As set out in clause 3 (Reg 59(c)(iv))

### **6) Prize Details**

**Prize:** One (1) x *meditation session with Trinity Curated Wellness*

**Approximate prize value:** up to \$100

**Total prize pool:** up to \$100

The prize:

- is not transferable, refundable or redeemable for cash, unless required by law; and
- must be used in accordance with the provider's availability and booking requirements.

## 7) Draw Method (Reg 59(g))

This Promotion is a **game of chance**.

**Draw date/time:** 5 March 2026

**Draw location:** *Online*

The winner will be selected using a method that provides each valid entry a **random and equal chance** of being drawn.

## 8) Winner Notification in Writing (Reg 59(e))

The winner will be notified **in writing** within **[2] business days** of the draw via the email address and/or phone number provided at the time of entry.

## 10) No Cost to Accept Prize (Reg 59(h))

The winner will not be required to incur a cost to accept the prize (other than a trivial cost).

For clarity, any optional travel costs or parking costs associated with attending the session are the winner's responsibility.

## 11) Redraw (Unclaimed Prize)

If the winner does not respond within **[7] days** of being notified, or is deemed ineligible, the Promoter reserves the right to conduct a redraw at:

**Redraw date/time:** 6 March 2026

**Redraw location:** *Online*

The redraw winner will be notified in writing in accordance with clause 8.

## 12) Record Keeping (Reg 59(f))

The Promoter will keep records for **3 years** after finalisation of the Promotion, including:

- an accurate financial accounting of the Promotion;
- an accurate accounting for all entries received; and
- an accurate report of prize distribution.

## 13) Privacy

Personal information collected will be used to:

- administer the Promotion;
- contact the winner; and
- verify eligibility.

Entrants can opt out of marketing communications at any time.

## 14) Disqualification / Integrity
